Minutes from the SEDOM Executive Board Meeting October 19, 2022

As of 8:35am, no members of the public were present, and Dr. Burns had not received any requested comments to be read during the public comment section.

The meeting of the SEDOM Executive Board was convened in person at 8:35am on Wednesday, October 19, 2022. In accordance with recent Executive Orders, Board President President Damisch declared that it was not possible for all board members to be physically present due to the construction occurring at the SEDOM Center which impacted recent COVID 19 mitigation efforts. Dr. Burns participated in person at the SEDOM center while four board members participated remotely from their home and or office in accordance with the recent Gubernatorial Executive Order.

Dr. Burns informed all members that the meeting would be recorded and available to the public. Dr. Burns further mentioned that it would be his intent to place a recorded copy of the meeting on the website however as GOTO-Meeting and WEB.COM were separate and private companies that he may need additional assistance to convert the file for posting.

The meeting was called to order at 8:35am.

Board Members that were physically present included Board President Damisch, Board Vice President Millard and Board Secretary Parks. Board Members Elswick, McTague and Neiss participated remotely.

Recognition and Identification of Visitors and Public Comment: No official visitors were present for the Executive Board portion of the meeting and no public comments had been received.

Communications: Dr. Burns discussed a recent I.M.R.F. review that was conducted.
